## AFFIDAVIT OF FINANCIAL SUPPORT

### PURPOSE OF THE AFFIDAVIT

International students are required by the US Immigration and Naturalization Service to show proof to Northland College of their ability to meet educational expenses for study in the United States before they can be issued an I-20 and start their visa application process.

Proper completion and submission of this affidavit is required (see "Instructions" for affidavit below). If more than one person will be providing funds, a separate affidavit must be completed by each sponsor. A bank statement or official letter confirming availability of funds must be attached to each affidavit.

### INSTRUCTIONS

1. The affidavit must be fully and properly completed in English and using the US dollar as currency. It must be typed or clearly printed in blue or black ink.
2. The declaration must be signed by the financial sponsor(s) or student; no one else may sign this section.

3. Supporting evidence of financial resources must be attached (in English and US Dollars) to the affidavit. An original letter or statement on official stationery must be submitted from a bank or other financial institution in which the sponsor has savings deposits, certificates of deposit, money market certificates or other types of accounts containing readily available funds, providing (1) date accounts opened, and (2) specific amount of funds in the accounts. This information must be dated within 120 days of the intended arrival date.
4. Faxed documents, bank statements older than 120 days from arrival, letters indicating enough funds are available without listing the actual amount available in the bank, income statements, pension funds, and funds that are not immediately accessible (i.e. stocks or bonds, investments, retirement documents, life insurance policy statements) are NOT ACCEPTED.
