

## Teach-Out Agreement

## Between

Northland College and the University of Wisconsin - Green Bay

This is binding agreement between Northland and the Board of Regents of the University of Wisconsin System d.b.a. the University of Wisconsin – Green Bay (UWGB) for the purpose of UWGB serving as a teach-out receiving institution due to the closure of Northland at the end of the 2024-2025 academic year. The terms of the agreement are as follows.

The University of Wisconsin-Green Bay will:

- 1. Subject to application deadlines, guarantee admission for any active Northland College undergraduate student, regardless of academic standing at Northland College, for the following terms. International students may be subject to additional requirements:
  - a. Summer 2025
  - b. Fall 2025
  - c. Spring 2026
- 2. Waive application fees for both undergraduate and graduate applications for Northland College students for the terms listed above
- 3. Transfer 100% of all undergraduate degree credit earned at Northland College towards the 120-credit graduation requirement.
- 4. Apply Northland College credits to as many UWGB undergraduate requirements as possible
- 5. Waive all undergraduate minimum degree residency requirements for students from Northland College.
- 6. Provide information and advising to Northland College students about options and pathways for completing their degrees. UWGB Academic Advisors will work with each student to ensure that degree completion is facilitated as quickly as possible.
- 7. For each student transitioning to UW-Green Bay from Northland College, the applicable undergraduate tuition to complete the required courses for graduation will be equal to or lower than the published tuition at Northland College during the student's last year of enrollment, with any potential tuition increases in future years equivalent to any overall undergraduate tuition increase at UW-Green Bay. Lodging/meal costs and other fees beyond the tuition will be charged at the published undergraduate rates for UW-Green Bay. Each Northland College student will be provided complete information about tuition and fees and any other costs associated with completing their degrees at UW-Green Bay. The tuition agreement outlined above applies only to students who have previously matriculated at Northland College.



## Northland College will:

- 1. Waive any fees for students sending official Northland College transcripts to UWGB
- 2. Provide UWGB faculty and staff access to course syllabi upon request.
- 3. Provide directory information for all active Northland College students, including date of birth.

## Both institutions agree:

Northland College

- 1. This teach-out agreement is contingent upon review and approval of the Higher Learning Commission.
- 2. To keep this agreement confidential until a mutually agreed upon time where details can be shared with students, faculty, staff, and the public.
